Terms and Conditions - All are available in the schedule & on website

- * The committee reserves the right to refuse an entry. All exhibitors enter at own risk
- * All Exhibits to be the bona fide property of the Exhibitor
- * An Agricultural Societies Council of NSW Sheep Show Health Declaration
- * MUST accompany all entries
- * All sheep must come from an Accredited Brucellosis Free Flock. A Brucellosis Certificate must be sighted by the Steward before Exhibits are unloaded
- * No sheep may be penned or compete if infected with footrot, any external parasites or disease
- * Sheep to carry no more than 12 months wool.
- * A lamb is defined as: An animal under 12 months of age or that does not have any permanent incisor teeth in wear
- * Depending on the numbers of entries, classes may be combined or divided
- * Handlers are required to wear stud or school uniform
- * If no sheep are entered in classes, prizes may be reallocated
- * Sheep are not to be exhibited unless from a property or flock for which a signed declaration is submitted with the application for entry, verifying that the exhibits have not for any period of their lifetime, been in a flock or on a property where the exhibitor has any reason to believe Ovine Johne's Disease is known or suspect to exist.
- * Handler age is taken as being age on the day of the Show.
- * Handlers classes with high numbers of entries will be split into heats with ribbons awarded in each heat. A final for each age group will then be conducted
